We had a unique request back in November of 2021. One of our patient's last dying request was to drink an "Olympia Beer". We thought easy request, we will stop by the grocery store, pick one up and request accomplished. Well as you continue to read, it wasn't as easy as we thought. We went to several grocery stores, convient stores and yes, liquour stores to be told they didn't have any. Come to find out, we were told that "Olympia Beer" was no longer being made and it was discontinued in January of 2021 during the COVID pandemic. Now we are between a rock and a hard wall! what to do! what to do! We put on our thinking hats, and upped our game. We needed to find just one can of "Olympia Beer", so we posted the request on Facebook. Low and behold, before we knew it, the story went viral. We were receiving calls from all around the U.S. There were news reporters calling our office trying to help spread the word through their news channel and local communities in hopes of finding someone out there to fill the patient's one last request. People were calling saying they saw the post on "Facebook", or that a friend of a friend shared the information or that they saw it on the news or heard about it on the radio. It was wonderful to see how many people came together to help find a beer for a patient on hospice care. We even had the owners of the Olympia Beer company contact us in hopes of helping us find the one can of beer!

If you are wondering, wonder no more we were able to find that one can of "Olympia Beer"! Mission accomplished!

We have had other patients with last requests such as a tamale during off season, or other food requests, but the Olympia Beer was a little bit harder to fulfill since the beer had been discontinued.

We would like to thank everyone who helped search for this patient's last request. People are truly amazing!



Director's Corner

A Message from John Williams, Executive Director



Hospice of Yuma was founded to give an option for dying patients to be able to be cared for at home surrounded by friends, family, and not have to spend their last moments of life in a hospital. That fundamental reason is a building block that started not-for-profit hospice care, beginning in the early 1970s, in the United States. Many changes have occurred over the past 4 decades in health care including hospice. The biggest change in hospice, however, has not been its best. The addition of the for-profit hospices has brought questionable practices and aggressive business models that have led to poor care, broken promises, and mistrust.

Community not-for-profit hospices like Hospice of Yuma, have had to weather these storms in a competitive and challenging healthcare environment. It is hard for people to believe that all hospices are not the same, but it is important for people to know this so they can make the best choice for their loved ones.

As of the 2019 statistics, which are the most recent available, there were 4,840 hospices in the United States, 71 percent were for-profit corporations. Why should that matter? Frankly, because there is a difference in the quality of care and commitment to local communities. Even though not-for-profit and for-profit hospices receive the same level of reimbursement, for-profit hospices often use strategies to reduce costs and generate more profit for shareholders or owners. These strategies directly reduce the care and quality of care patients receive. Comparative examples based on multiple studies performed over the last decade have concluded the following:

Not-for-profit hospice providers:

- Spend more on comprehensive care per patient
- Provide more care in home settings
- Discharge patients before dying at a lower percentage
- Re-admission for hospital care is 50% less
- Admit higher cost and higher acuity patients, like those diagnosed with cancer
- Admit all patients with a terminal illness, seven days a week
- Provide no-cost comprehensive bereavement services to ALL in the community

For-profit hospice providers:

- Spend significantly less per patient than not-for-profit hospices
- Provide less care in home settings
- Have higher nursing caseloads and lower nursing visit frequency than not-for-profit Hospices
- Discharge patients at a higher percentage before death
- Re-admit twice as many patients to hospitals for care
- Admit fewer higher-acuity and cancer patients because of cost
- Provide minimal bereavement services

Not-for-profit hospices invest dollars in clinical education to enhance care, offer higher visit frequencies, more care, and yes – we also accept patients regardless of ability to pay. At Hospice of Yuma, we believe our mission is important to those facing end-of-life and to the communities in Yuma County we are privileged to serve. We believe it is important for you to know whether the hospice providing care for your loved one is primarily focused of generating profit or is a truly patient focused hospice committed to the highest quality of care for your loved one. You have a right to be informed and a right to choose your hospice provider.

Annual Memorial Service



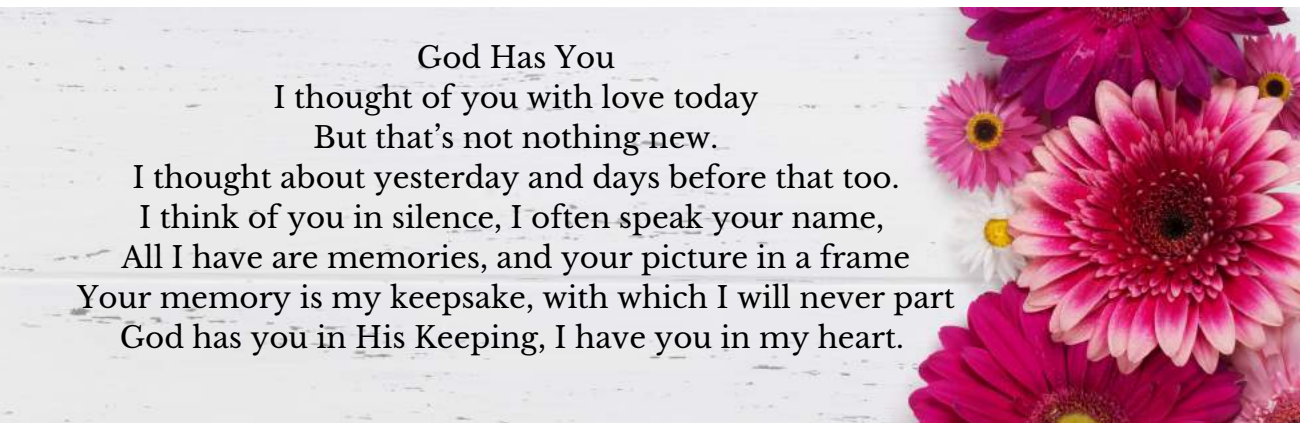

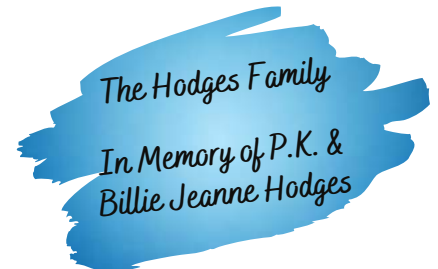

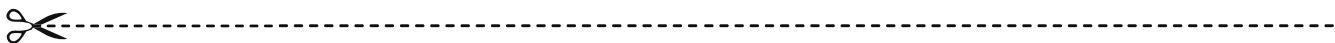
